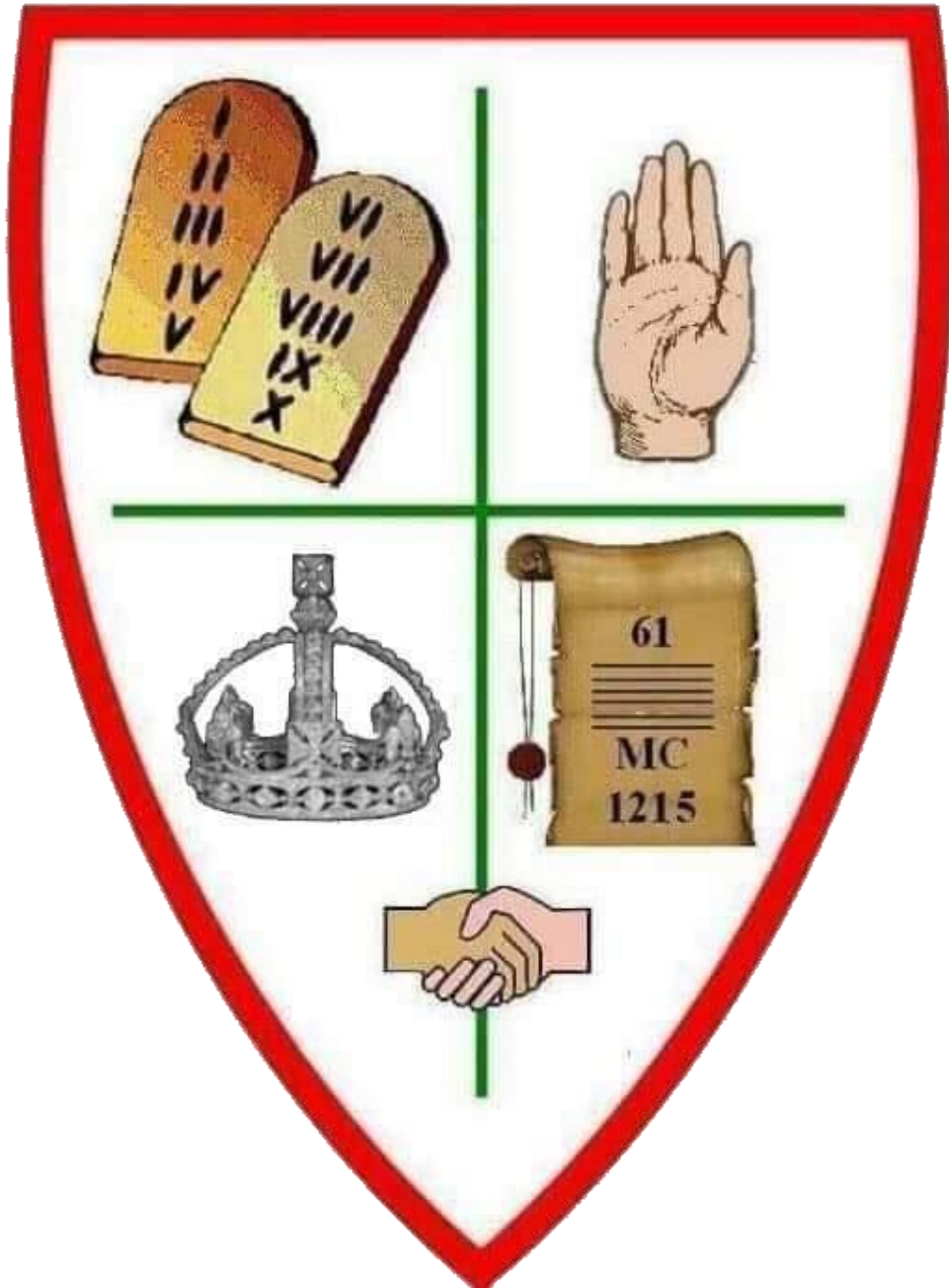


# OATH OF ALLEGIANCE TO BARONS' COMMITTEE WHOM INVOKED ARTICLE 61

## *Why do we recommend taking an Oath to this Committee of Barons?*

- Royal Command, under Magna Carta, explicitly instructs us to transfer our allegiance to such Committee upon their invocation of Article 61.
- This adherence to Royal Command – Law under Article 61 – places us firmly within the Law as we carry out further duties at Royal Command and leaves no question of our Lawful intent.
- The Committee of Barons is absolutely held to Magna Carta and cannot compel any of us to break Common Law – therefore we place no risk upon ourselves by swearing an Oath to them. We are only following the Lawful procedure under Article 61 and evidencing our Lawful standing.

### *Royal Command as per Article 61:*

**“All those, moreover, in the land who of themselves and of their own accord are unwilling to swear to the twenty five to help them in constraining and molesting us, we shall by our command compel the same to swear to the effect aforesaid.”**

4. Send the photocopy Registered Mail to the address provided below. Keep receipts for your Registered Mail safe as evidence of your Lawful standing. Collect whatever evidence you can: pictures, etc.
